OVERVIEW

The South Santiam Watershed Council (SSWC) is seeking individuals who want to be a part of a student-centered, dynamic outdoor education program to serve as part-time, temporary Outdoor School Educators. The educators will work closely with the SSWC Education staff to help deliver outdoor learning experiences for sixth-grade students from Sweet Home School District. Outdoor School occurs outside of Sweet Home at Camp Tadmor.

This position requires employees to stay overnight during the duration of Outdoor School (May 27th through May 30th). Housing and food are provided. Dietary restrictions cannot be accommodated.

ABOUT US

The South Santiam Watershed Council (SSWC) was created by residents of the watershed in 1995. The SSWC is a community-based organization that promotes voluntary actions to improve watershed health. The SSWC is a staple in outdoor education for students in East Linn County, and is currently conducting numerous habitat restoration projects throughout the South Santiam Watershed. ABOUT OUTDOOR SCHOOL

The South Santiam Watershed Council, in partnership with the United States Forest Service, has been providing Outdoor School for sixth-grade students in the Sweet Home School District for the past 11 years. Outdoor School is a 3-day, 2-night experience centered around outdoor learning and STEAM education standards. Participants work through nine learning stations, led by both paid educators and partner organizations. Learning stations vary per year. Previous learning station topics included fishing, archery, wildlife biology, ecology, forest management, nature art, and river ecology. Outdoor school educators will be in charge of guiding students

through a series of nature journaling related activities and facilitating learning station activities. Other activities include supporting High School Leaders, helping with campers' skit presentations, fireside songs, recreational activities, and more! Days typically run from 6:30 am to 9:30 pm with several opportunities for breaks throughout the day.

TRAINING DATES

Prior to Outdoor School, educators must attend five training sessions led by the SSWC Education Coordinator. Training sessions occur outdoors and at various locations throughout the South Santiam Watershed basin. In addition to the five training sessions, educators must attend one high school camp counselor training session and one teacher's meeting. More information about responsibilities for those events below. All training sessions and teacher meetings are paid.

The training sessions are as follows:

RESPONSIBILITIES

- Participate in 5 educator training sessions. Dates listed above.
- Attend at least one teacher's meeting.
- Attend at least one high school camp counselor training session.
- Read the Outdoor School curriculum packet and be familiar with the contents.
- Facilitate outdoor learning experiences for up to 20 sixth grade students per learning group. Educators work with one learning group per learning station session.
- Engage students with flexible and dynamic learning experiences to best meet students where they are.
- Help foster community within student learning groups.
- Periodically meet with the Education Coordinator to discuss progress, strategy, and challenges.
- Assist with Outdoor School set up and take down.
- Attend our paid Outdoor School staff and teacher debrief (TBD).

ATTRIBUTES FOR SUCCESS

- Commitment to providing outdoor education experiences that centers participant experience
- Experience working with students from economically and racially diverse backgrounds (including students who are low income, Black, Indigenous, and People of Color (BIPOC)
- Familiarity with forest and river ecology, middle school math concepts
- Ability to adapt and be flexible in content delivery methods and activities
- Ability to be flexible in a dynamic environment

If offered a position, candidates must:

- Pass a criminal background check
- Demonstrate that they have a valid driver's license and vehicle, or ability to arrange reliable transportation to and from the training session sites, high school visits, and Camp Tadmor.
